- WARM-UP/  
WARM-DOWN:** Warm-ups and warm-downs must be supervised by a USA swimming registered "Coach Member" following guidelines established by the LSC. **Supervising deck coaches shall have their USA Swimming Registration card prominently displayed at all times. The Meet Referee and Marshal(s) will enforce registration rules regarding coaches.** Disregard of the USA Swimming safety rules will be grounds for disqualification of swimmer from competition.
- RULES:** Current USA Swimming and Hawaiian Swimming rules will govern meet.
- FORMAT:** Timed finals, using semi-automatic timing system (three buttons) with manual watch backup. The meet shall be conducted in split sessions. The second session shall start approximately 1 hour after the completion of Session 1 events. The "four (4) hour rule" will be in effect for swimmers of age 12 and under.
- DIVISIONS:** Session 1:  
Individual Events: 11-12, 13-14, 13-18, 15-16, 17-18  
Session 2:  
Individual Events: 8&U, 9-10, 10&U, 11-12
- EVENTS:** See attached
- ELIGIBILITY:** All swimmers must be currently USA Swimming registered and their registration numbers must be on the master entry form or entry file. No deck registration will be accepted. **All new registrations must be mailed directly to the LSC Registrar and postmarked no later than 5 days before the meet date.**

- ENTRIES:** Swimmers may enter a maximum of three (3) individual events. Swimmers are allowed to swim only one session per day. Fines for swimming out of classification will be based on the LSC database results of the past 2-year schedule. Master Recap sheets must be included with the entries.
- DISTANCE EVENT REQUIREMENT:** Swimmers must have achieved a HI-A time in the 100 M/Y length of a stroke for entry into the 200 M/Y length of the same stroke.
- I.M. EVENT REQUIREMENT:** Swimmers must have achieved a HI-A time in at least one (1) of the four (4) 100 M/Y strokes or 100 I.M. for entry into the 200 I.M.
- ENTRY FEES:** \$3.00 per swimmer entered per day and \$3.00 per relay entry, **plus \$1.00 LSC Fee per swimmer entered per day.**

- Entry fees must accompany entries OR be submitted to Clerk of Course upon check-in. No refunds will be made.
- DEADLINE:** Hy-Tek Meet Manager will be used. **Entries must be RECEIVED NO LATER than Tuesday, September 11th, 2007 (5 days prior to meet).** No late entries will be accepted at the meet.

- CHECK-IN:** This meet will be pre-seeded. **Scratches for Session 1 individual events are DUE BY NOON on Saturday, September 15.** Scratches for Session 2 individual events are due to the Clerk of Course thirty (30) minutes after the start of Session 1.
- Coaches need to personally present their credentials to pick up heat sheets from the Clerk of Course; exceptions must see the meet referee.
- AWARDS:** Individuals will be awarded ribbons for 1st through 8th places in each age group division and classification.
- RESULTS:** Results will be posted on the Hawaiian Swimming website. Hard copy of meet results will be provided only upon request.
- OFFICIALS:** Each team is required to provide one (1) official for every five (5) swimmers entered in the meet. For those clubs entered with less than five (5) swimmers, at least one (1) official will be required. Timers are considered officials. Teams may be pre-assigned timer lanes.

- HOSPITALITY:** Refreshments will be available for Officials and Coaches during the meet. Lunch will be provided for Deck Officials and Coaches.
